As of September 30, 2015 there were **738** active, paying members including **10** life members and **13** junior members. There were 0 renewals in September.

In September we received and processed 8 guest requests for complimentary electronic bulletins. The total number of guests receiving a three-month complimentary email notification of electronic bulletin availability is **70**. In addition, there are 33 businesses, agencies and libraries as well as 3 other outdoor clubs who receive a printed bulletin at no charge.

**Communications and Club Promotion-** Steve Dougherty presented in Mike Pennington's absence. Mike Pennington and Rob Kimmich have developed a printable list of Chemeketan "activities" from the web site. This list can be sorted by type of activity (ski, snowshoe, hike, climb), date or leader. Rob has also updated the website to more easily locate activity leader contact information.

**Insurance-** Steve Dougherty moved to cancel the 3<sup>rd</sup> party liability insurance. Mark Olson seconded this. It was decided by 5:1 vote to cancel the policy.

**Print Bulletin Subscription-** Steve Dougherty moved for members who wish to receive a printed bulletin pay a subscription fee to help defray the cost for printing and mailing the monthly printed bulletin beginning in 2016. Fletcher Adelman seconded this. It passed unanimously. A work group will meet in mid October to explore the following: amount of a

print bulletin subscription fee and how the bulletin will get printed and mailed. Invitations to the work group will be given to the 3 Bulletin editors- Joanne DeMay, Bill Geibel and Mike Berger as well as a few members of the Executive Council. Recommendations will be brought back to the full Executive Council at the November meeting for a vote.

**Executive Council Election Update-** Submitted by Karen Craven via e-mail.

1. Valley Mailing is sending out the ballots today (Tuesday). Paula Hyatt and her crew are all set to count the votes. Deadline for returning ballots is Oct 31.

Karen also announced via e-mail: Ann Hanus has had success in negotiating space with Ike Box for the picture nights. We can have the main ballroom the 2nd Friday of each month for free. Participants will be encouraged to purchase beverages from the coffee shop (but of course that is not a requirement to attend.) We'll start in January.

**Den Cleanout-** This is on hold until after the Fall election results. However, Susan LaTour did announce a need, when the time comes, for a few strong folks to help carry stuff down the steps out to her truck for disbursement/disposal.

**Annual Banquet:** Susan is looking for a date without major conflicts for the Annual Banquet this Spring. She is trying to sign Steve Amen of Oregon Field Guide for the keynote speaker.

**Bylaw amendment recommendations-** Mary Liepins will submit a proposed bylaw change, addressing the timing of the annual meeting, in the December bulletin.

**Snowshoeing Committee report,** submitted by Steve Dougherty following a phone call from Committee Chair, Lee Slatum, earlier today.

Lee intends to schedule one show shoe activity per weekend from December until March and one midweek snowshoe activity per month (weather permitting).

**Cross Country Skiing Committee report:** Ted Young, committee chair, identified 5 ski trip leaders. They are: Ken Ash, Dave Carter, Don Gallagher, Roz Shirak, and Georgienne Young. In addition to day trips, a few overnight trips are being planned. (ie, sleeping in lodges and skiing 2 days, NOT sleeping in the snow)

Ted also announced Senior Ski Week at Diamond Lake is Feb 1-5 2016. This event features groomed trails, and an absence of snowmobiles. Food and lodging is provided by Diamond Lake Lodge. You can take the train from Salem to Chiloquin and catch the shuttle to the lodge. Watch the bulletin to sign up early, space is limited.

**Dawdler Hike Committee report-** Carol Soderberg is the Dawdler Hike committee chair. Carol spoke of the dawdler hikes serving as a good introduction to the club. Fifty five dawdler hikes a

year have been scheduled. Carol says more hike leaders are needed. Paula Hyatt leads many of the 3 mile hikes, sharing her vast knowledge of the outdoors. Carol tends to lead longer hikes, usually in the 6 mile range.
