*Judith Ann Zineski joined the Chemeketans on May 4, 2004 and remained a member through 2010. She lived in Portland and moved to Fort Bragg, CA. She died January 3, 2016 (due to liver/bile cancer) at the age of 63. In the Barbara Bond book "Take A Hike Portland" she was acknowledged: "Judith Zineski expanded my wildflower identification skills exponentially. Thanks, Judith." She led hikes for both the Chemeketans (November 2007 Bulletin) and the Mazamas (found on OregonHikers.org). She contributed articles to "Common Lives, Lesbian Lives" in the mid 1980's. She was a member of the Native Plant Society of Oregon in 2006. On June 3, 2007, she climbed Mt Elinor (WA) via the SE Chute with the Mazamas.*
