Chemekeden	The President is authorized to permit use of den by adult groups sympathetic to aims and goals of the Chemeketans providing the following conditions are met: a) an adult Chemeketan is present; b) occasional use only (not regular meetings); c) if damage occurs it must be repaired by the user.	
1975, Apr.	Chemekeden	An American flag, presented as a gift by Harriet DeGuire, will be displayed in the clubroom.	
1996, Jan.	Chemekeden	The Chemeketan Cane shall be awarded a place of honor in the clubroom and the system of awarding the cane to the hiker who has completed the most hikes shall be abolished.	
1997, Feb.	Chemekeden	A Cabin/Den Trust Fund will be set-up for the development, repair and updating of the Den and Cabin.	
2003, May	Chemekeden	The deed for the Den includes a clause stating that the east staircase be accessible to users of the building for emergencies. The Council will check with the lessors and talk to the owners to the east to ensure the Chemeketans retain access to the east stairway at both the sidewalk and the head of the stairs. Concluded the deed gives sufficient assurance for continued use of the Den for the foreseeable future so there is no further reason for an alternative Den site. The deed clause does not ensure access to the east stairway for moving Outing equipment.	
2006, June	Chemekeden	A Den Improvement committee shall be formed and given a tentative limit of \$5,000 to complete the work.	
2006, Sept.	Chemekeden	The Den Chair is authorized to spend up to \$100 per month on Den supplies and maintenance without pre-approval.

1959, Oct.	Climbing	The Climb Committee shall take inventory of all climbing equipment at the end of each year and turn it over to the next committee.	
1964, Jan.	Climbing	Only Chemeketans and guests are allowed to use the climbing equipment. Key to climbing equipment to be held by Chemekeden chairman.	
1966, Apr.	Climbing	Present and future acquired ropes for Chemeketans are NOT to be rented or loaned (they are reserved for official club climbs).	
1966, May	Climbing	A second key to climbing equipment room to be held by Club president.	
1972, Mar.	Climbing	Climb Committee will no longer rent climbing equipment and Committee authorized to dispose of	

		equipment on hand with the exception of the ropes.	
1965, May	Climbing	A \$5.00 deposit be required for Chemeketan climbing equipment rental by non-members, \$1.00 of amount to apply to the weekend of the climb; a promised return date be requested at time of rental and \$.30 be charged for each day equipment kept beyond climb date. Appointment of someone responsible for rent of equipment to be made by Climbing Chairman and his committee.	
1965, Sept.	Climbing	Leaders are exempted from paying climbing fees.	
1967, Apr.	Climbing	Half of climbing fees be retained for the trips chairman for payment of unusual and necessary expenses; balance to be reported to the Council annually.	
1967, May	Climbing	A climber under 18 shall present to the leader written permission from parent; a climber under age 15 will be accompanied by a responsible adult with the leader to have decision in determining number of youngsters for which an adult shall be responsible.	
1971, Jun.	Climbing	Climb leaders instructed to refuse any person wanting to climb who does not have the proper equipment. Junior members must have permission of their parents and if under 16, must be under the supervision of an adult.	
1969, June	Climbing	On record as supporting climbing leaders in making safety regulations on their climbs.	
1969, July	Climbing	As long as the leader is abiding by the accepted safety precautions, Council is behind him 100% at all times. Any exception to the above rule may be made only at the discretion of the leader.	
1969, Aug.	Climbing	Climbing rules adopted: 1) Lug soled boots (vibram cleats) required on all climbs; 2)Crampons and ice axes on all snow climbs; 3) Hard hats required on Mt Jefferson, Three Fingered Jack, Mt Washington, North Sister and where otherwise specified by the leader; 4) Carabiner and sling rope on all climbs where roping up will be necessary; 5) Two carabiners and two sling ropes on any climb where a rappel will be necessary; 6) At least Chemeketan rock practice is strongly recommended as a prerequisite for a rock climb. Exceptions to the above may be made only at the discretion of the leader of the climb.
